Details should be given on the signing in screen so these are available for track and trace if required.</p> <p>Phone numbers will be taken on the entry screen system under the 'Visiting' section for Track & Trace.</p> <p>Visitors will be asked to not attend if they have any Covid symptoms, and also asked to confirm they have no symptoms before entering the school.</p> <p>Hampshire Children's Services, Adult Services & Property Services contractors will be asked to show the evidence of their negative Covid test as per School Communication SC018590.</p>	<p><i>If a risk assessment has not been given prior to the visit (unexpected but official visitor – police, children's services etc) a verbal summary will be given, and a copy of this assessment will be available on the schools reception desk.</i></p>

		<p>Visitors who cannot show a negative Lateral Flow Test result when arriving will have their temperatures taken before entry.
